Judge John F. Gerry was appointed to the United States District Court for the District of New Jersey by President Gerald R. Ford in 1974. Recognized for his humanitarianism and integrity, Judge Gerry became the District Court's Chief Judge in 1987, and served in this position until October 1994. The Camden County Bar Foundation established the John F. Gerry Memorial Scholarship in 2002 as a tribute to this popular and respected longtime public servant.

Candidates for the Judge Gerry Scholarship must be currently enrolled in a New Jersey law school, demonstrate academic achievement and genuine financial need, and exhibit a history of public service and/or a desire to work in public service law.

Applicants must submit this completed application, a copy of their law school transcript (website version is acceptable) and additional pages as necessary. Applications must be received in the Camden County Bar office by 5 p.m. on Monday, September 30 to be considered.
