
The court will be closed until the ceremony concludes, so we hope you make every effort to attend this special ceremony.



CCBA Lawyer Referral Service and Lawyers

Enrollment is now open for the Association's Lawyer Referral Service (LRS) for the 2023-24 Bar year. Panel membership is open to any lawyer who meets the necessary qualifications. The new LRS panel will begin on June 1 and continue through May 31, 2024. Members serving on the current panel must re-enroll for the new LRS year.

Each year, the LRS makes some 3,000 referrals for callers with legal problems who are able to afford a private attorney; many of them fee-generating cases. You can be a part of this important program that helps expand your client base through pre-screened referrals while providing terrific community services for individuals requiring legal services.

The annual registration fee remains only \$75 for those admitted to the New Jersey Bar for up to five years or \$150 for those admitted six years or more. Please note that all LRS panel members are required to remit back to the Association 10% of fees collected in excess of \$500 for all matters referred by the LRS. The fee applies to any referral received from the LRS and is payable when the participating attorney receives payment for services rendered.

A completed application, together with the appropriate enrollment fee and required original certificate of malpractice insurance coverage, must be returned to the Bar Association before any referrals can be made.

Planning for Spouses with Disabilities in a Family Law Setting

In planning for spouses with disabilities in a Family Law setting careful analysis must be made of the spouse's immediate needs and also what, if any, public benefits the spouse is receiving or may be entitled to receive in the near future. Financial issues impacting

the spouse would be alimony and equitable distribution. Alimony is income to the spouse and would affect any public benefits the spouse is receiving that are based on income. Equitable distribution constitutes a transfer of assets to the divorcing spouse. Depending on the nature of the assets, this may affect public benefits that have asset tests. The first step is to identify whether the spouse is receiving public benefits, then determine what the eligibility requirements of those benefits are, and then design a strategy or strategies that would enable the spouse to maintain or obtain those benefits.

Common Benefits

Common benefits include the following:

- > <u>Supplemental Security Income (SSI)</u>. SSI is an income benefit payable to an individual with disabilities. Income, including alimony, affects eligibility. There is an asset test of \$2,000, so equitable distribution may affect eligibility.
- SSI-linked Medicaid. SSI recipients automatically receive Medicaid. The income and asset tests are the same as for SSI. Therefore, both alimony and equitable distribution may affect SSI-linked Medicaid.
- Medicaid Waiver Programs. Many individuals with disabilities receive benefits under Medicaid Waiver Programs that pay for services such as home care, assisted living, and nursing homes. The primary program furnishing these services is Managed Long-Term Care Services and Supports (MLTSS). There is an income cap of \$2,740 per month under this program, and an asset limit of \$2,000. Therefore, both alimony and equitable distribution may impact eligibility for this benefit.

- > <u>Federally Assisted Housing</u>. Eligibility for Federally Assisted Housing is based on both income and assets. The income is dependent on the area in which the individual resides. There is an asset limit of \$100,000. Therefore, consideration for both alimony and equitable distribution could affect eligibility for Federally Assisted Housing.
- > <u>Supplemental Nutrition Assistance Program (SNAP)</u>. This program is commonly referred to as Food Stamps. There is no asset test for this program, but there is an income test. Alimony could directly affect eligibility. Equitable distribution would not affect eligibility indirectly. If the assets transferred as a part of equitable distribution produced income, this would affect eligibility.
- > <u>Low-Income Home Energy Assistance Program (LIHEAP)</u>. LIHEAP has an income test, but not an asset test. Therefore, alimony could affect eligibility. Equitable distribution would affect eligibility only indirectly.

Strategies

Strategies to be considered in designing a settlement for divorce would include long-term care planning strategies involving spenddown and transfers of assets. These strategies were discussed in a previous article. In addition, a Self-Settled Special Needs Trust would solve the problem. Which strategy is preferable must be analyzed on a case-by-case basis.

> <u>Self-Settled Special Needs Trust.</u> A Self-Settled Special Needs Trust is a trust funded with the assets of the individual. In the case of alimony, the monthly payments would be considered income of the spouse with the disabilities. In the case of equitable distribution, the assets received by the spouse with disabilities would be considered assets of the spouse with the disabilities. If the alimony is irrevocably assigned by court order to a Self-Settled Special Needs Trust, the alimony would not affect eligibility for income tested public benefits. If assets received in equitable distribution are transferred to a Self-Settled

Special Needs Trust, this would not affect public benefits that are asset tested. The requirements of a Self-Settled Special Needs Trust are:

- <u>Assets of the individual.</u> Alimony and equitable distribution would meet this test.
- Age. The individual must be under age 65 at the time the trust is funded. Alimony payments received after age 65 pursuant to the court order obtained prior to age 65 would be protected.
- <u>Disability</u>. The individual must be disabled as defined by the Social Security Act. Typically, the individual would have a Disability Determination Letter from the Social Security Administration.
- Benefit. The trust must be for the sole benefit of the individual with disabilities.
- <u>Establishment.</u> The trust must be established by the individual beneficiary, or a parent, grandparent, guardian, or the court.
- <u>Payback.</u> The State Medicaid Agency must be reimbursed for any benefits paid on behalf of the spouse with disabilities on the death of that person.
- · Irrevocable. The trust must be irrevocable.
- <u>Discretionary Authority.</u> The trust must give the trustee discretionary authority to make distributions.
- ➤ <u>Estate Planning Documents</u>. As a part of a divorce consideration should be given to the spouse with disabilities addressing Estate Planning documents. Any prior Estate Planning documents will probably no longer be effective, because typically they would leave the estate of the

divorcing spouses to one another and the spouses would appoint each other as executors, trustees, health care representatives, and powers of attorney. The divorce would likely change all of those prior intentions.

- Will. The Will of the divorcing spouse should address the issue of who would be the beneficiary of the divorcing spouse's estate. Would it be children? If so, would trusts be required due to age or other circumstances? Who would be the executor? Who would be the trustee? Who would be the guardian of minor children?
- <u>Health Care Power of Attorney.</u> Who would make the medical decisions for the divorcing spouse, if that individual is unable to make them for themselves? Does the divorcing spouse want to be kept alive artificially if there was no hope of recovery?
- Power of Attorney. Who would make financial decisions for the divorcing spouse if that individual was no longer to make them for themselves? What types of financial decisions would be contemplated? Would gifting be a practical provision if the divorcing spouse needed public benefits in the future? If so, special language must be included. The document must also include authority for the agent under the Power of Attorney to make gifts to himself or herself if that is the intention of the principal executing the Power of Attorney; otherwise, such gifts are prohibited.

Reconstructing Tax and Financial Records

When Marty Abo was in Naples last month, he proudly stood by to listen to CNN interview his son, Dr. Benjamin Abo, for his commentary regarding the building collapse in Iowa (Ben was often called by the media after his month long search-rescue efforts

during a similar building collapse in Miami let alone his expertise called upon during hurricane Ian). It seems this year has also seen more than its share of natural disasters, from devastating fires in Hawaii; a hurricane, flooding and landslides in California to crippling tornadoes in Mississippi and Tennessee. And with hurricane season now starting anew, more disasters are bound to strike. Along with property losses, many victims of natural disasters will lose some or all of their financial and tax records and will be faced with the daunting task of reconstructing these records so they can prove the amount of their losses from personal-use and business property. Failure to do so can cost thousands in lost federal assistance, insurance reimbursements, and tax deductions.

If your clients or their business experienced losses from a natural disaster, we offer our condolences (and to you, if you are the claimant). As for reconstructing the client's or your records, this letter provides some simple steps that your client (or you) can take now to help get the job done. It will take some work, but it will be worth the effort in the long run.

Tax Returns. If any of the prior year tax returns have been destroyed, give us a call. We can likely provide you with copies. If a different practitioner prepared your prior year returns, we could help you get free return transcripts



via the "Get Transcript" tool on the IRS's website. They or you also can order transcripts by calling 800-908-9946 and following the prompts. Last, but not least, Form 4506-T (for transcripts) or Form 4506 (for tax return copies) can be filed with the IRS to get the needed information. To expedite processing and to waive the normal user fee, write the appropriate disaster designation in red letters across the top of the form.

Personal Residence and Real Property. If a personal residence or any other real property, such as a vacation or rental home, was damaged—

- Take photographs or videos as soon after the disaster as possible. This helps establish the extent of the damage.
- Contact the title company, escrow company, or bank that handled the purchase of the home to get copies of appropriate documents. Real estate brokers also may be able to help.
- Use the current property tax statement for land-versus-building ratios, if available. If they are not available, one can usually get copies from the county assessor's office.
- Establish a basis or fair market value of the home by reviewing comparable sales within the same neighborhood. This information can be found by contacting an appraisal company or visiting a website that provides home valuations.
- Check with the mortgage company for copies of appraisals or other information they may have about cost or fair market value in the area.
- Review insurance policies, as they usually list the value of a building, establishing a base figure for replacement value insurance.

- If improvements were made to the home, contact the contractors who did
 the work to see if records are available. If possible, get statements from the
 contractors verifying their work and cost.
- Get written accounts from friends and relatives who saw the house before and after any improvements. See if any of them have photos taken at gettogethers.
- If there is a home improvement loan, get paperwork from the institution that issued the loan. The amount of the loan may help establish the cost of the improvements.
- For inherited property, check court records for probate values. If a trust or estate existed and your firm handled the estate or trust or you know the lawyer who did, confer with the attorney who handled the estate or trust. We may be able to help as well if you previously provided this information to us.
- If no other records are available, check the county assessor's office for old records that might address the value of the property.

Vehicles. If a vehicle was damaged or destroyed in a disaster, there are several resources that can help determine the current fair market value of most cars on the road. Resources such as Kelley's Blue Book, National Automobile Dealers Association, and Edmunds are all available online and at most libraries. Also, perhaps reach out to the dealer where the car was purchased and ask for a copy of the contract. If this is not available, give the dealer all the facts and details, and ask for a comparable price figure. If making payments on the car, check with the lien holder.

Personal Property. It can be difficult to reconstruct records showing the fair market value of some types of personal property. Here are some things to consider when cataloguing lost items and their values:

- Look on mobile phones for pictures that were taken in the home that might show the damaged property in the background before the disaster.
- Check websites that can help establish the cost and fair market value of lost items.
- Support the valuation with photographs, videos, canceled checks, receipts, or other evidence.
- If items were purchased using a credit card or debit card, contact the credit card company or bank for past statements. Credit card companies and banks often provide users' access to these statements online.
- If there are no photos or videos of the property, a simple method to help remember what items were lost is to sketch pictures of each room that was impacted. These do not have to be professionally drawn, just functional. Draw a floor plan showing where each piece of furniture was placed—include drawers, dressers and shelves. Take time to draw shelves with memorabilia on them and be sure to include garages, attics, closets, basements, and items on walls.

Business Records. If your or your client's business experienced a loss from a disaster, you'll need to reconstruct those records as well.

- To create a list of lost inventories, get copies of invoices from suppliers.
 Whenever possible, the invoices should date back at least one calendar year.
- Check mobile phones or other cameras for pictures and videos taken of buildings, equipment, and inventory.
- For information about income, get copies of the bank statements. The deposits should closely reflect what the sales were for any given time period.
- Get copies of last year's federal, state, and local tax returns. This includes sales tax reports, payroll tax returns, and business licenses from the city or county. These will reflect gross sales for a given time period. The firm's CPA will have copies of returns they (or we) prepared for you. If you have previously provided the accountants with copies of other returns, we or they may have a copy of those as well.

- If there are no photographs or videos available, sketch an outline of the inside and outside of the business location. Then start to fill in the details of the sketches. For example, for the inside of the building, record where equipment and inventory were located. For the outside of the building, map out the locations of items such as shrubs, parking, signs, and awnings.
- If the business was preexisting and acquired, go back to the business broker for a copy of the purchase agreement. This should detail what was acquired.
- If the building was newly constructed, contact the contractor or a planning commission for building plans.

There you have it. It'll take some work, but it will be time well spent. Please give us a call if we can be of assistance. Oh, one last thing. 

I hope most of you were able to cope with the seemingly daily thunderstorm forecasts and enjoy time at your favorite spot on the beach, in the mountains, or at your backyard grill. Golfers among us probably canceled a round or two needlessly (those storms really were scattered), while on other occasions found themselves far from the clubhouse when the skies actually did open and jagged bolts made the cart seem slower than it was. Fortunately for us, we avoided the record heat that prevailed in other parts of our

During the publishing hiatus of *The Barrister*, I was able to attend a New York City tasting of wines from Austria and Germany that was jointly presented by Skurnik Wines & Spirits and The German Wine Collection. Most of the 47 wineries participating were represented by owners or winemakers pouring an array of their wines, allowing questions to be posed to people who knew the answers. While many behind the tables were familiar faces, there were a few producers with which I was not familiar, enabling me to further broaden my wine horizons. I was particularly pleased to catch up with Andreas Wickhoff representing Austrian producer, Bründlmayer. In 2017, at a restaurant in Sydney, Australia, Linda and I shared a bottle of wine

with Andreas, a Master of Wine, and this was my first time since then to chat with someone who really knows wine, particularly that made in his native Austria.

While there were many impressive wines offered that typically earn high critical scores from major publications at correspondingly lofty prices, since our primary focus is on wines that offer quality and affordability, let's talk about some of those I tasted at this gathering that will be easy on the wallet.

If there is a grape variety most associated with Austria, it probably is Grüner Veltliner (GROO-ner Velt-LEAN-èr). It is the most widely planted varietal in Austria, and while the wines can achieve splurge-worthy excellence, many producers offer entry level bottles that represent good value. Among the most reliable and affordable Grüners is the 1000 ml. bottling by Erich Berger, and his latest release is no exception. 2022 Berger Grüner Veltliner is a dry, round wine with prickly acidity and fruit that resembles pear and apple. While the varietal can present spices like white pepper and subtle vegetal qualities, this wine is driven more by its clean, overt fruit. So, take me to your liter!

Another top-quality Austrian producer is Hiedler, and the **2022 Hiedler Loess Kamtal Grüner Veltliner** once again offers an excellent insight into the varietal. Loess is a silt laden soil having a composition that is loose (from which the name originates), making it very



suitable for vineyards. This wine has a chalky character, with chewy, medium weight fruit that is made more subtle by the character the soil imparts and by a salinity that is particularly noticeable on the finish.

Another Grüner Veltliner worth considering is 2022 Glatzer Carnuntum Grüner Veltliner. This offers some of the more typical expressions of the grape with its gently spicy notes overlaying a touch of snap pea impressions. However, there are additional layers to add interest, including lanolin and quinine that escort lime and green apple fruit that are forward and reasonably weighty while augmenting a sneaky, lingering finish.

Let us now look at a modestly priced Austrian red wine made from what now is the most widely planted red grape in that country, Zweigelt. The grape is named for the man who engineered it by crossing two traditional Austrian grape varieties, St. Laurent



and Blaufränkisch. **2021 Setzer Zweigelt** would be a good choice for a late summer barbecue or with pizza, taking advantage of its broadly extracted black fruit flavors bolstered by black pepper notes that help to expand the overall mouthfeel. There is nothing subtle or nuanced about this wine, but it will suit many casual dinner needs.

Perhaps a few dollars cheaper and yet a bit more refined is **2019 Prieler Oggau Johanneshöhe Blaufränkisch**. It is a bit richer in its extracted expression, with dusty blackberry fruit, soft tannic grip, and subtle acid tension with nuanced slate tones carrying the taste to its conclusion. Blaufränkisch is a grape variety that has other names, most notably

for American consumers, Lemberger (not to be confused with the cheese known as Limburger). It is a variety that can handle colder temperatures, which works in the Finger Lakes and Washington State, among other American locations, but has yet to achieve the popularity to justify growing it in lieu of other varietals.

While it probably is not a grape that most consider when looking to Austria, Pinot Noir is part of the winemaking arsenal of some producers, one of which, Johanneshof Reinisch, does an excellent job at several price points. Its **2021 Johanneshof Reinisch Estate Pinot Noir** is the entry level Pinot Noir and shows very nicely, exhibiting deep red cherry fruit that is both round and textured. It has a clean, fleshy feel and a gently soft finish. While it lacks some of the grip and character of the winery's pricier bottlings, it represents very good value for a varietal that often costs more.



Let's now turn to a few German wine values by starting with one of the more popular favorably priced Riesling entries, 2022 Hexamer Quarzit. For many years, Harald Hexamer has been one of the more visible and personable producers in the Skurnik stable of German wineries, but this year Harald stayed home and sent his son, Magnus, in his place. While this is not a dry Riesling, the residual sugar is subtle enough to enhance the wine's dimension without detracting from the very clean and ripe fruit for which this bottling long has been known. In the balancing act between residual sugar, even at the modest level here, and the acidity for which Riesling is known, this wine's structure keeps the sweetness in check and for fans, the smiles in place.

If you prefer dry Riesling, then there are many we can discuss. Let's start with one that makes its intentions very clear, the **2022 von Buhl Bone Dry Riesling**. The peach and apricot fruit profiled here is full and pulpy, with ripeness and weight created by the fruit itself and not the retention of perceptible residual sugar.

Two other excellent examples of dry Riesling are offered by the Spreitzer family, which, founded in 1641, like many German producers has a long history. 2022 Spreitzer Estate Riesling Trocken ("trocken" means dry) is a well-chiseled wine that offers angular stone fruit impressions that are at once penetrating yet refreshing. For a slightly higher price, the old vines dry Riesling from this producer also merits consideration. 2022 Spreitzer Alte Reben Riesling Trocken ("alte reben" means old vines) provides perhaps a touch more depth and structure with more minerality as a counterbalance to the still rich fruit. There is a more citric impression in this version

that expresses itself in a more linear fashion than does the broader Estate Riesling.

Another impressive dry Riesling entry is the **2022 Dr. Bürklin-Wolf Estate Riesling Trocken**. The saline and slate drive to the steely peach fruit makes this wine both clean and quaffable and ready to pair with food such as fish and chicken dishes.

Let's conclude our journey by highlighting one of the most consistent creators of fairly priced German wines, Darting. A dry Riesling that is a mouthful from both a taste and labeling point of view is the 2022 Darting Durkheimer Fronhof Riesling Kabinett Trocken. While many of the Kabinett level wines one encounters allow the ripeness of the grapes to be expressed within a designated range of residual sugar,

this wine has been vinified trocken by converting most of the sugar into alcohol. Despite achieving the lowest QmP level (there are 6 "Qualitätswein mit Prädikat" levels, or quality wines with distinction, based on increasing amounts of residual sugar), and its dry fermentation, this wine is rather muscular, not so much because of the alcohol level (which remains modest by today's standards), but rather due to the heft of the fruit it possesses. There is a solid sense of apples and apricots with a touch of allspice that adds to the overall vivid taste expression.

If you avoid Austrian wines because they are unfamiliar or German wines because you believe they will be too sweet, you may be surprised by what you find and can appreciate for their versatility and affordability. **Prost!**


