## Working Together . . . Lawyer Referral, Law Firms & Lawyers

Open Enrollment Begins for 2018-2019 Lawyer Referral Service Panel

Enrollment is now open for the Association's successful Lawyer Referral Service (LRS) for the coming year. Panel membership is open to any lawyer who meets the necessary qualifications. The new LRS Panel will begin on June 1, and will continue through May 31, 2019. Members serving on the current panel must re-enroll for the new LRS year.

Each year, the LRS makes more than 5,000 referrals for callers with legal problems who are able to afford a private attorney to LRS Panel members; many of them fee generating cases. You can be a part of this growing venture that helps expand your client base through prequalified referrals for the cost of a good dinner at one of the area's fine restaurants. This is the only Lawyer Referral Service sponsored and operated by the Camden County Bar Association, and provides a terrific community service for individuals requiring legal services.

The annual registration fee remains only \$75 for those admitted to the New Jersey Bar for up to five years or \$150 for those admitted six years or more. Please note that LRS panel members are subject to a fee sharing arrangement whereby attorneys are required to remit 10% of fees in excess of \$500 for all matters received from the LRS back to the Association. The fee applies to any referral received from the LRS and is payable when the participating attorney receives payment for services rendered.

A completed application, together with the appropriate enrollment fee and required original certificate of malpractice insurance coverage, must be returned to the Bar Association before any referrals can be made.

# The Impact of Crowd-Funding on Individuals Receiving Public Benefits

## **Crowd-Funding**

People often utilized an online device known as "crowd-funding" to raise money for certain purposes. Popular online websites include GoFundMe, Indiegogo, and Crowdrise. These websites allow users to fundraiser for individuals and personal causes. They are often very effective ways to raise money. On other occasions, crowd-funding is done outside of online sites, such as 5k runs, potluck dinners, etc. Typically, the funds from these events are deposited into a "trust" in a bank for the benefit of the ultimate beneficiary.

## **Public Benefits**

Sometimes the beneficiary of the crowd-funding is an individual receiving means-tested public benefits such as SSI, Medicaid, Food Stamps (SNAP), heating assistance (LIHEAP), federally-assisted housing (Section 8), pharmaceutical assistance, etc. Many of these benefits have income and asset limits. For example, an individual receiving SSI and Medicaid can only have \$2,000 of assets in his/her name. If the individual benefits from crowd-funding and receives more than \$2,000, the individual will be over-resourced and will lose those benefits.

## **Alternatives**

There are five alternatives for the individual receiving means-tested public benefits:

- 1. Accept the Money. This option means that the beneficiary will accept the money and forego pubic benefits. Before making this decision, an analysis should be made as to the value of the public benefits being lost. For example, in New Jersey the maximum SSI payment is \$766.65 per month. Over a year, this is \$9,199.80. For five years, the total would be \$45,999.00. Actually, it would be a little more, because the SSI payment is indexed to inflation. What is the cost of replacing Medicaid including premiums for private insurance, deductibles, copays, etc.?
- 2. Spend Down. If the amount realized through the crowd-funding is not large, the individual may be able to spend the money down in the month received. There would be an overpayment for that month, but as long as the money is spent before the first day of the next calendar month, benefits would not be lost. Typical spend down items include: cars, houses, home improvements, debt repayment, clothing, etc.

- 3. *Transfer the Funds*. If the individual with disabilities transfers the funds received from the crowd-funding to a third party for less than fair market value, there is a transfer of asset penalty. For all practical purposes, the transfer of asset penalty for SSI is three years. During that three years, SSI is lost and Medicaid is lost as well. This is not usually a good solution.
- 4. Special Needs Trust. A Special Needs Trust will protect the individual's public benefits, because the money in the Special Needs Trust is not counted as an asset. If the amount raised is relatively small, i.e., \$150,000 or less, consideration should be given to depositing the money in a Pooled Trust administered by a non-profit disability organization. If the amount exceeds \$150,000, the money should be deposited in a standalone Special Needs Trust administered by a professional trustee.

If the money from the crowd-funding is payable to someone other than the individual with the disabilities, such as the parents, then the parents can establish a Third Party Special Needs Trust and deposit the amount raised into that Trust. These trusts are more flexible to administer and do not require a Medicaid payback on death.

If the money from the crowd-funding is payable to the individual receiving public benefits, then a First Party Special Needs Trust is required. Again, the money in the trust is not counted as an asset of the beneficiary, but there are strict rules. One rule is that the money can be used only for the sole benefit of the individual with disabilities. Another is that any money remaining in the trust on the death of the beneficiary must be first used to repay Medicaid.

5. *ABLE Account*. An ABLE account is an account that can be managed by the individual with disabilities or a family member. There is a limit of one account per individual. The maximum contribution in any one calendar year is the amount of the federal gift tax annual exclusion, which for 2017 is \$14,000. ABLE accounts are a very useful tool, because the individual can control some of the assets. In addition, monies paid from the ABLE account for food and shelter do not impact the amount of the SSI payment.

## **Establishing the Special Needs Trust**

So long as the individual with disabilities is not the creator of the campaign and the funds from the crowd-funding campaign have not been paid to the individual, a Third Party Special Needs Trust can be established. If the funds have been paid to the individual, a First Party Special Needs Trust must be established. The best situation is to have the funds payable from the crowd-funding campaign directly to the trustee of the Third Party Special Need Trust. If the beneficiary is the creator of the crowd-funding campaign, the funds will belong that individual and a Self-Settled Special Needs Trust will be required. If a third party is the creator of the campaign, proceeds can be paid to a Third Party Special Needs Trust. Prior to launching the campaign, the creators must understand these ramifications. At the time the trust is funded, the beneficiary, the trustee, and any attorney involved in

drafting the trust should meet and determine what immediate cash needs the beneficiary has and develop a monthly budget. If possible, a credit card should be obtained for the beneficiary. The beneficiary can then charge budget items to the credit card and forward the credit card bill and receipts to the trustee on a monthly basis. If items are required that are not on the budget, the beneficiary must contact the trustee in advance. For a Third Party Special Needs Trust, it is recommended that someone other than the beneficiary establish the trust. This could be a parent, a family member or friend. The establishor simply signs the trust document. The trustee of a Special Needs Trust, whether Third Party or First Party, should always be a professional or a disability organization. Administration of Special Needs Trusts is complex. First Party Special Needs Trusts receive a considerable amount of oversight from the State Medicaid Agency.

## Do you Want to Help Bridge the Justice Gap in New Jersey?

South Jersey Legal Services, Inc. (SJLS) serves the legal needs of the poor in Atlantic, Burlington, Camden, Cape May, Cumberland, Gloucester, Monmouth, Ocean and Salem counties and provides free legal services in some civil cases to clients whose income and assets are within established limits. SILS always has a need for bankruptcy attorneys, family law attorneys, attorneys willing to help children who have been denied disability benefits and attorneys willing to help individuals expunge their criminal records. Below are some of the volunteer opportunities available. Thank you to all Camden County attorneys who consistently volunteer their time. If you would like to volunteer, please contact Michelle. T. The **Pro Bono Bankruptcy Project** refers bankruptcy cases in two ways (1) through our joint program with the bankruptcy bench/bar and Rutgers Law School – Camden where attorneys work with law students to help our clients file for Chapter 7 and (2) through individual referrals directly through SJLS, outside of the Rutgers Project. Applicants are currently waiting 4-5 months to get assigned an attorney. SJLS works with the clients prior to making any referral to get much of the necessary document gathering done before the file is referred.

To participate in **The Divorce Project**, a client must be seeking dissolution of the marriage only. There can be no asset or debt issues and child support and/or custody must already be established by court order.

The **Family Assist Project** provides 30-minute advice consultations to individuals in need of family law advice. Appointments are held once per month either in the SJLS local office or at the attorney's office if the attorney prefers. Attorneys are provided with any relevant court orders. There is no obligation for further assistance beyond the advice consultation.

The SJLS **Expungement Project** helps individuals who need to expunge their criminal records. Because of the recent changes in the law, SJLS has received a large number of expungement requests. Many of these individuals need the expungements in order to secure employment or better housing.

The **Children's Supplemental Security Income (SSI) Project** assists children who have been denied disability benefits. This Project was started in 2006 and has resulted in many favorable decisions for children in New Jersey and their families. SJLS provides training materials if needed.

Attorneys who certify that they have performed at least 25 hours of voluntary qualifying *pro bono* service in New Jersey are exempt from being appointed to take a Madden v. Delran *pro bono* case for the following year under Rule 1:21-12.

March is a busy month for tasting wine, particularly if one has access to the many opportunities offered to those in or connected to the wine trade. I headed-up to NYC for two of the three tastings to which I had access during five days early last month, enabling me to search out wines for us to discuss this month.

The first tasting is an annual one I enjoy attending presented by the Slow Wine organization, the vinous equivalent of the "slow food" movement that began 30 years ago in northern Italy. The concept is to focus more attention on responsible production of agricultural products, in this case wine. In the past, the organization promoted only Italian producers and their wines. This year, six California wineries were invited to attend. While there were some very nice wines offered by these U.S. producers, their cost puts them beyond most people's idea of good value, so I shall focus on some of the Italian wines made by wineries that enjoy good distribution in our country.

One of the features of this tasting is that a number of the wineries pouring their wines do not have, but are looking for, a U.S. distributor. While it can be fun to taste wines that currently are not available in our country, they would be of little interest to those who find a wine described here interesting enough to search out. So, let's talk about a few wines that, fingers crossed, will be found in our market.

Initially, let's focus on a grape that often is overlooked when American consumers are buying wines from Italy's Piedmont region. **2014 G.D. Vajra Barbera d'Alba Superiore** offers some very high-toned fruit



resembling blackberries, presented within a nicely supple and fairly bountiful body. The acidity really is mouthwatering, making this a wine poised to pair with meat and pastas. I made a point to visit with Giovanni Pasquero Elia, one of the brothers behind the Paitin label that long has been a part of the Moore Brothers select inventory. The **2015 Barbera d'Alba Serra** is, perhaps, a bit redder in its fruit impression than the Vajra, but again it offers nice acidity, particular for this vintage, with the broad and expansive flavor profile a warmer year can offer. **2014 Casa E. di Mirafiore Barbera d'Alba Superiore** is in many ways similar to the Vajra. It offers more of the black fruit, although perhaps showing a touch more black cherry, with a medium body that, again, is framed by brisk acidity. The finish in this wine is perhaps the most enduring of these Barberas.

If Barbera is not in your wine sights, I suspect a wine made from a blend of Barbera, Sangiovese and Sagrantino may seem even more foreign. However, if you run across the **2014 Tabarrini Montefalco Rosso Boccatone**, and the price is attractive, you may want to consider it. The flavor profile is a bit darker than the above wines and, owing no doubt to the Sagrantino in the blend, there is an earthy gaminess to the very dark, black fruit. To add complexity, there are nuances of graphite and underbrush commanding one's attention.

If we venture south to Italy's Tuscany, the 2015 Badia a Coltibuono Chianti Classico is a complete and lovely wine. The fruit is red cherry with a touch of mulberry and it extends broadly from opening to the finish without any sharp edges. While the wine displays the acidity one looks for in the Sangiovese grape, it does not intrude on the fruit impressions, but rather escorts them with a firm but velvety grip through the long ending. Another winner from the very fine 2015 Tuscan vintage is the 2015 Poggio al Sole Chianti Classico. My impression of, and thus notes for, this wine is that it shares many of the attributes of the Badia a Coltibuono. The fruit and grip are really quite similar, with the most noticeable difference seeming to be a slightly lower level of fruit intensity. Both, however, are fine examples of top flight Chianti.

Let's now focus on a few white "Slow Wines" for your warmer weather enjoyment. A venerable Veneto producer of white wines is Pieropan. It is a fairly large estate that focuses on making Soave, and their entry level wine almost always is reliably good. **2016 Pieropan Soave Classico** is a crisp wine that offers lithe rather than broad vanilla and citric fruit

exhibiting veins of almonds. It is crafted from the two main grapes of Soave wines, Garganega and Trebbiano. In Italy's Marche region, a grape that thrives is Verdicchio, and a nice rendition of this varietal is offered by 2016 Pievalta Verdicchio dei Castelli di Jesi Classico **Superiore**. Verdicchio is thought to share DNA with Trebbiano, although as a varietal it is fairly limited in the regions in which it is grown. There are two primary types of Verdicchio in the Marche, that which, like this one, is grown around the commune of Jesi, and those from grapes grown around Macerata, called Verdicchio di Matelica. The Matelica versions tend to be regarded more highly, in part because the allowable grape yields are lower increasing the potential for quality. Candidly, my notes for this wine are not much longer than its name. I found the wine that to show spicy notes over citric fruit that is crisply delivered. It is a clean wine that will be compatible with lightly sauced chicken and fish dishes.

The other early March tasting I attended was the Skurnik Grand Portfolio tasting. As you may recall from past reports, the Skurnik brothers have built and maintained an enviable portfolio of producers during the past 31 years, and each March they bring together many of the winemakers/owners to pour their wines (and increasingly spirits and beer). With 194 tables of wine, spirits and beer (thankfully for us, mostly wine), it is possible in four hours to barely scratch the surface of what is on offer. I'll save many of the wines I managed to taste for another column, but I wanted to mention a few as we close out this month's discussion.

I had a nice visit and chat with Laely Heron, a very genial and ambitious producer of both domestic and foreign wines. I made sure to stop at her table because her focus is



on value, and she manages to hit that sweet spot in the marketplace with regularity. While all the wines being poured were very good, I thought the best was the **2016 Heron Wines** Mendocino Sauvignon Blanc. Sauvignon Blanc has become increasingly popular, thanks in great part to the success of those brought to us from New Zealand. The hallmarks of many New Zealand versions are their impressions of green grass and boxwood (less gently characterized as cat pee). These wines may have as many detractors as fans. If that style is not to your liking, perhaps this wine will work for you. It conveys a richer presentation, with ripe fruit that largely lacks the aggressively herbal notes that can be found in wines from this grape. Unlike many U.S. Sauvignon Blancs, which often are more expensive, this wine does not use oak to please Chardonnay fans but is a clean melon and apple fruited wine that is easy

Another wine producer to look out for is Andrew Latta and his relatively new project, Disruption Wine Company. His motto pretty much sums up his approach—"more wine, less ego." Andrew cut his teeth working for Charles Smith, about whom I have written in the past. Charles achieved tremendous success (and wealth) with his Washington State wine ventures, building a strong following for wellmade and cleverly marketed wines, five of

which he sold in 2016 for a reported \$120,000,000. Andrew undoubtedly had a hand in that success, and, realizing the potential, left Charles Smith and began producing his own wine. Not unlike Smith's (now Constellation Brand's) popular Kung Fu Girl Riesling, the **2016 Disruption Washington State Riesling** has crowd pleasing potential. It offers peachy Riesling flavors that are round with (and likely because of) a touch of residual sugar. It is a fleshy wine for those who really prefer something slightly off-dry and eminently quaffable. Cheers!

## **CCBA Members are Givers...**

Yep, it's Abo. But not reciting forensic or valuation insight or ideas. Nope. With tax returns and damages reports flying about me, I had to break away last month to see the Camden County Bar's presenting the highest honor it can bestow, the Hon. Peter J. Devine Award, to its greatest "giver", Brenda Lee Eutsler, Esq. (a/k/a CCBA's Energizer Bunny). With tax season here and many concerns expressed about charitable contributions in 2018, what a perfect time of year to remind you, as charitably inclined professionals, to at least think taxes now rather than merely wait for the preparation of your income tax returns. Those attorneys who incur out-of-pocket expenses while volunteering may be well advised to request any required acknowledgements from the charity well before it's time to actually file your return.

## A little background

A charitable deduction is not allowed for a contribution of services (we get this question all the time, from many an attorney, without fail). However, unreimbursed out-of-pocket expenditures made to render volunteer services to a charitable organization may be deductible. The expenses are treated as direct payments to the charity, rather than for the use of the organization. To be deductible, the out-of pocket expenses must be nonpersonal, directly connected with, and solely attributable to providing the charitable services. Expenditures that primarily benefit

you that are incurred in a charitable purpose are not deductible as charitable contributions. For example, baby-sitting fees your esteemed President-Elect, Ronald Lieberman, may incur are just not deductible even if his munificent volunteer work cannot be performed without the expense.

Examples of deductible out-of-pocket expenses include uniforms unsuitable for everyday use, copying charges, office supplies, long distance phone charges, postage, local transportation from your home to the place charitable services are performed, and other travel incurred while providing services for the charitable organization. Travel expenses incurred while away from home, such as meals (subject to the 50% travel and entertainment limitation) and lodging, are deductible only if (a) there is no significant personal pleasure, recreation, or vacation in the travel, and (b) the performance of services is substantial.

You, as a volunteer, incurring out-of-pocket expenses must keep detailed records for those expenditures to be deductible. If the total of such expenses is \$250 or more for a single charitable activity, you really should have a written acknowledgement from the charity describing the services provided and indicating whether you received any goods or services (including value) from the charity in consideration. The amount of out-of-pocket expenses need not be shown on the acknowledgement.

The acknowledgment must be obtained *before* the earlier of (a) filing the return or (b) the return's extended due date. You should have the acknowledgment when the return is filed, even if this is before the extended due date. You can't amend a return to include contributions for which an acknowledgment is obtained after the original return is filed.

## 2018 Tax Law Changes

Ever since passing the new tax act, all charities became concerned about the dampening effect on charitable deductions due to lowering tax brackets and increase of the standard deduction (not even considering the major increase in estate tax exemption). Many a taxpayer will not itemize since the standard deduction effectively doubles to \$12,000/\$24,000. This dialogue will ensue even while we prepare 2017 returns and look to 2018 where we've at least suggested they at least consider "bunching" charitable donations (i.e. instead of \$5,000 in 2018 and \$5,000 in 2019 where they might get no benefit if they are still under the standard deduction, consider paying \$10,000 in one year to get over the \$12,000 or \$24,000 threshold for that year). They can at least reap some benefit. While fewer taxpayers may take itemized deductions for their charitable giving in 2018 and on, the individual income tax changes will clearly reduce the average marginal tax benefit of charitable giving from 20.7 percent to 15.2 percent. While the marginal tax benefit of charitable giving will decline significantly for low- and moderate-income itemizers, it will hardly change for the higher-income taxpayers. Also, appreciate those subject to the dreaded Alternative Minimum Tax (AMT), including yours truly, still get a benefit from charitable contributions (albeit not at the maximum 37%) rate). If you are subject to AMT, your tax bracket is 26%-28% for AMT.

**Bottom Line:** It is imperative for you to have all required receipts before filing your return, even if that means extending the return. Although many charities automatically provide written acknowledgements to their donors, except with certain quid-pro-quo donations (where the volunteer received goods or services because of the volunteer services), they do not have to do so. Therefore, it is usually you as the donor responsible for requesting and obtaining this documentation from the charity. In the case of your volunteering and incurring out-of-pocket expenditures, the charity receives no check, so it will often not know that the acknowledgement is needed until it is requested.

**Abo's Conclusion:** Unreimbursed out-of-pocket expenses incurred while rendering volunteer services to a charity may be deductible, but only if the expenses are properly documented and, if the expense exceeds \$250, a proper acknowledgement is received from the charity. This acknowledgement must likely be requested by you. 
